REEVE H BETTS FELLOWSHIP

Tribute to Dr. Nemish Ambalal Shah

Tribute to Dr. Ravindra S. Rathore



31.01.1924 - 08.06.2008

Dr. Nemish Ambalal Shah was born on January 31, 1924. He was married to Mrs. Rukhmini Shah daughter of Lord and Lady Kania, first chief justice of India.

Dr. Shah did his undergraduate studies at the KEM Medical College where he won the gold medal in both medicine and surgery. He did his Masters in General Surgery KEM Hospital and won the gold medal in his subject. He was trained in thoracic surgery and did FRCS in general surgery. He became the professor of cardio vascular and thoracic surgery at the JJ Group of Hospitals. He was the founder director of the first department of cardio vascular and thoracic surgery in Bombay Hospital Institute and Medical Science, Mumbai. Here he pioneered the start of open heart surgery in a private setting by experimenting first with dogs and later on used non disposable metal oxygenators and homemade pericardial valves to start successful cardiac surgery on humans in the hospital. He did angiography on his own patients. He was very popular cardiac surgeon all over India.

He was extremely interested in pediatric and valve surgery and was unparalleled in infective lung surgery. He also started coronary artery bypass surgery and was among the first to use the internal mammary artery as a conduit. He was the president of the Cardio Vascular Society of India and also a founder member of several other Indian, Asian and international societies in cardiology and cardiac surgery. He retired from the Bombay Hospital at the age of 80 and lived a quiet life in his beautiful home in Mumbai. His wife, Mrs. Shah expired in January 2008 and Dr. Shah himself appeared to have lost his will to live after she had gone and expired at home on the night of June 8, 2008.

Dr. Shah will be mourned by his family and all of us in the medical fraternity who knew him well as a great surgeon, a wonderful teacher and a friend, philosopher and guide to all his juniors. Peace be with him.

Dr. Ravindra Singh Rathod, young & energetic cardiac surgeon worked at Narayana Hrudayalaya, Bangalore did his MBBS in 1987 and M.S. in Gen. Surgery 1994. He qualified for M.Ch. degree in 1997.

He worked as Junior Consultant at Manipal Heart Foundation upto 2000. He did one year fellowship in paediatric surgery in children hospitals at Westmead and another year fellowship in adult and paediatric surgery in Prince of Wales Hospital, Sydney. He worked in Townsville Hospital, Queensland and Royal Adelaide Hospital upto 2005. He returned to India in 2005 and was working at consultant cardiac surgeon at Narayana Hrudayalaya.

He was gentle, courteous and efficient as a person and as part of any surgical team. He shall be remembered as an affable personality and good cardiac surgeon.

He is survived by his wife and daughter.
